

Saturated Absorbents – Store all saturated absorbents in the cans labeled “Saturated Absorbent.”

Aerosols – All aerosols **MUST** be properly disposed of; give aerosol cans requiring disposal to your Sierra Army Depot contact for proper handling.

Plastic Materials - Please dispose of in specially marked bins.

Wood Pallets – Place used pallets in the designated areas.

Hazardous Materials and Waste-

Proper handling, storage and disposal of your Hazardous Materials and Hazardous Waste should be coordinated through your Sierra Army Depot POC and the Environmental Office.

ENVIRONMENTAL POLICY

Sierra Army Depot (SIAD), is a member of the Army’s Organic Industrial Base reporting to U.S. Army TACOM Life Cycle Management Command (TACOM LCMC). SIAD considers the environment and safety to be of paramount importance and is committed to leadership and stewardship in protection of the environment and workplace safety. Environmental and safety management is based on the principles of continual improvement, sustainability, hazard identification, and control and pollution prevention as appropriate in furtherance of our goal of protecting our environment and our workers.

Sierra Army Depot complies with applicable federal, local, and state regulations in addition to other requirements for the support and storage of military assets. SIAD reviews the environmental objectives and targets annually or when new types or work are received. At no time is any operation allowed unless it can be demonstrated that the operation will be performed safely, is environmentally sound, and in compliance with all regulations, installation policies, and guidance documents to minimize impacts on air, ground and water.

Sierra Army Depot conducts operations in a manner, which protects the community and minimizes or prevents adverse impact to environmental media through environmental controls. The installation protects its workers through the application of hazard identification, risk assessment and implementation of risk controls. Environmental and safety controls take precedence over shortcuts, expediency or acts of convenience.

The materials specified above are processed and configured at our recycling center. If you have any recycling questions, ask your Sierra Army Depot POC.

- White Paper

- Various Liquids
- Plastic

- Cardboard

Each one of these Environmental Aspects is managed with Sierra Army Depot operational controls.

Energy Use – Conserve energy by turning off lights and equipment when not in use.

Computer Waste – Do not dispose of any computer related items in the trash without first contacting your Sierra Army Depot representative for specific instructions.

Paper – Ensure that all paper is recycled in the paper recycling bins.
